

Job Title: Learning Disability Nurse – Billericay

Location: Hybrid - community-based role with travel across GP practices and Hamelin sites

Role Purpose

This is an exciting opportunity to help launch and deliver innovative 12 month pilot programme designed to improve health outcomes for people with learning disabilities in Billericay.

Working in partnership with GP surgeries within Billericay, you will play a pivotal role in increasing uptake and quality of Annual Health Checks (AHCs) and ensuring every patient receives a meaningful, personalised Health Action Plan (HAP).

You will be responsible for setting up and delivering the clinical elements of the pilot for your region, building strong relationships with primary care and voluntary sector partners, and providing clinical oversight to ensure safe, effective, and person-centred support.

A key part of the role will be recruiting and line managing a Health Care Assistant (HCA) to support delivery.

In addition, this role will contribute to the development and future delivery of a targeted vaccination programme for people with learning disabilities, ensuring equitable access, reasonable adjustments, and improved uptake (timelines to be confirmed).

Key Responsibilities

Project Leadership & Delivery

- Lead the mobilisation and delivery of the project for your defined geographical area.
- Develop pathways and processes to support delivery of Health Action Plans (HAPs) following GP led AHCs.

- Ensure delivery aligns with project outcomes, including increasing AHC uptake to at least 50%.
- Monitor and report on progress, outcomes, and impact.

Clinical Oversight & Practice

- Provide clinical leadership for the development and delivery of person-centred HAPs.
- Ensure all interventions are evidence based, safe, and tailored to communication needs.
- Support individuals to achieve health goals (e.g. weight loss, smoking cessation, reduced isolation).
- Identify clinical risks and escalate appropriately.
- Provide guidance and support to GP practices on reasonable adjustments and LD specific care.
- Contribute to the delivery of a vaccination programme for people with learning disabilities as part of a related Hamelin project (timelines and scope to be confirmed).
- Work with GP practices and partners to increase uptake of vaccinations within the LD population and their wider networks.
- Support individuals to understand the benefits of vaccination and address barriers to access.

Partnership Working

- Build strong relationships with GP surgeries across your area.
- Work collaboratively with Essex Disability Alliance partners.
- Act as a bridge between primary care and the voluntary sector.
- Support practices to improve accessibility and engagement for patients with LD.

Service Development & Innovation

- Co-design accessible and meaningful HAPs with patients and families.
- Develop tools and resources to improve patient understanding and engagement.
- Deliver AHC education sessions for people with LD and their families.
- Contribute to learning and evaluation to inform future service expansion.

Line Management & Team Development

- Recruit, train and line manage a Health Care Assistant.
- Provide supervision, support and performance management.
- Ensure high-quality, consistent delivery of interventions.

Outcomes & Impact

- Ensure all patients on the LD register are offered a HAP.
- Support achievement of improved health outcomes for at least 80% of participants.
- Contribute to reducing health inequalities and avoidable deaths in the LD population.
